**RENTAL ASSISTANCE FUNDS ARE AVAILABLE TO HELP: All DC evictions are cancelled until the Mayor ends the public health emergency, but rents are still due. These rental assistance funds are limited.... Apply for assistance and submit ALL required documents quickly before funds run out!**

- COVID-19 Housing Assistance Program (CHAP): provides up to three months (maximum of \$4,250) of rental assistance for eligible DC tenants who have been affected by the public health emergency. - Emergency Rental Assistance Program (ERAP) provides rental assistance for eligible DC tenants who are at least 30-days delinquent in rent or who are homeless and need assistance to rent an apartment. - 202Assist Rental Assistance Program provides up to \$1,000 for eligible tenants in DC's Ward 8 affected by the public health emergency. To apply contact Lydia's House at 202-373-1050 or download the application at <https://www.lh4us.org/forms> to apply.
- Assistance for Persons Living with HIV/AIDS (PLWH): HCS' MHAP Program offers assistance with rent, mortgage, utilities, food, and other necessities in D.C, Prince George's, Montgomery, Charles, Calvert and Frederick Counties.
